Subscription plans allow for external searching and are Grantor/Grantee Search only.

Tract Search can be used externally or while searching at the County office and allows for Grantor/Grantee and Tract/Legal Searching.

Copy Accounts are for printing documents while at the Register of Deeds office.

A separate log in is required for each type of plan; Subscription, Tract and Copy.

To sign up for Laredo please return the Laredo Agreement including user name and password along with the escrow deposit to the Antrim County Register of Deeds office. You will be notified via email when your user name and password have been activated. Please allow 2-3 business days for activation. After account is activated you will need to download Laredo by visiting [www.fidlar.com](http://www.fidlar.com) clicking on the Products link and selecting Laredo.

Laredo plans and copies will need to be paid via an escrow account set up with our office. Please see minimum escrow requirements in the table above. An escrow account will need to be established along with a minimum deposit before requested user name is activated. To set up an escrow account, please contact our office at 231-533-6683.

Changes to plans must be completed in writing and by the 5<sup>th</sup> of the month. Changes will take effect the following month.

**\*\*PLEASE REMEMBER WHEN YOU ARE LOGGED IN TO LAREDO WITH A SUBSCRIPTION PLAN OR A TRACT SEARCH LOG IN MINUTES ARE BEING CALCULATED FROM THE TIME YOU ARE LOGGED IN UNTIL YOU LOG OUT. BEST PRACTICE IS TO LOG IN, COMPLETE YOUR SEARCH AND LOG OUT. ONLY STAY LOGGED IN TO LAREDO WHEN ACTIVELY SEARCHING.**
